

## **Bristol Fourth of July Committee Privacy Policy**

---

Bristol Fourth of July Committee is committed to transparency in regard to how we treat personal and business information that is collected through our ticketing and registration services.

### **What this Privacy Policy Covers**

- This Privacy Policy covers how Bristol Fourth of July Committee treats personally identifiable information and all other private information collected on the Bristol Fourth of July Committee ticketing and registration system, whether that information is collected via the Bristol Fourth of July Committee website, mobile service, or call center.
- This privacy policy does not apply to the practices of event producers, event organizers, and/or third-party companies that Bristol Fourth of July Committee does not own or control.

### **Collection and Use of Personal and Financial Information**

- You can visit the Bristol Fourth of July Committee website and browse events without revealing any personal information. However, Bristol Fourth of July Committee needs certain personal information if you wish to purchase tickets or register for events through its system.
- Where required, this information may include your personal contact information and/or your company contact information, and possibly credit card information as applicable. Bristol Fourth of July Committee may use this information to contact you about an event you set up, or about tickets you have purchased.
- Your user name, contact name, Bristol Fourth of July Committee login, or alias may be publicly displayed and connected to your activity on Bristol Fourth of July website. The public may view the date you set up your Bristol Fourth of July Committee account, comments you post on your Bristol Fourth of July Committee profile or events, your profile information, and events you have listed on the website.
- Bristol Fourth of July Committee will never sell your information.
- However, if you purchase tickets or register for an event through the Bristol Fourth of July Committee system, your personal contact information will be provided to the organizer of the event you purchased tickets to or registered for. Bristol Fourth of July Committee has no control over what an event organizer does with your information, and this privacy policy does not apply to the practices or actions of event organizers. An event organizer may choose to use analytic tools or click-through tracking from their event pages.
- By purchasing tickets or registering for an event through the Bristol Fourth of July Committee system, you voluntarily provide Bristol Fourth of July Committee with your personal information, and you consent to the collection and use of the information in accordance with this privacy policy.

### **Collection and Use of Non-Personal Information**

- Bristol Fourth of July Committee automatically receives and records non-personal information on our server logs from your browser including your IP address, cookie information, and the page you requested when you visit [fourthofjulybristolri.com](http://fourthofjulybristolri.com). We may use this information to better serve you by providing a customized shopping experience.

### **Third Party Websites and Services**

- Bristol Fourth of July Committee employs other companies and individuals to perform tasks and functions on our behalf, and we need to share your information with them to provide our services to you. Examples include, but are not limited to, fulfilling orders via sending postal mail and e-mail, processing credit card payments, handling billing disputes and collections, and providing customer service.
- Some Bristol Fourth of July Committee features include access to, and integration with, social media tools that allow you to manage content, access social media, and post content on social network platforms (for example Facebook and Twitter). - Bristol Fourth of July Committee reserves the right to terminate the ability of any third-party service to link to, integrate, or interact with any of the Bristol Fourth of July Committee features at any time, with or without notice, and at the sole discretion of Bristol Fourth of July Committee. Bristol Fourth of July Committee accepts no responsibility for reviewing changes or updates to, or the quality, content, policies, nature or reliability of, any Third-Party Services.

#### **When Bristol Fourth of July Committee Will Release Personal Information to a Third Party**

- Bristol Fourth of July Committee may release your personal information to a third party in order comply with a subpoena or other similar legal procedure. - Bristol Fourth of July Committee may disclose personally identifiable information to parties in compliance with our Copyrights and Intellectual Property Policy. Bristol Fourth of July Committee, in our sole discretion, in connection with an investigation of fraud, intellectual property infringement, piracy, or other unlawful activity, may disclose name, address, country, phone number, email address and company name.

#### **Contact from Bristol Fourth of July Committee**

- On occasion, Bristol Fourth of July Committee will send you messages via email. Some messages from Bristol Fourth of July Committee are service-related and required for users with accounts on Bristol Fourth of July Committee website. Examples of service-related messages include, but are not limited to a welcome/confirmation email when you register your account, your order confirmation, notices of a change in your event, or correspondence with the Bristol Fourth of July Committee support team.
- Additionally, Bristol Fourth of July Committee may provide you with newsletters regarding upcoming events, new and existing Bristol Fourth of July Committee features, or other information. You will always have the ability to easily opt out of any such newsletters.

#### **Cookies**

- Bristol Fourth of July Committee uses "Session Cookies", which are deleted when you close your web browser or complete your browsing session.

- Bristol Fourth of July Committee uses Session Cookies to:

1. Make our website work as efficiently as possible.
2. Administer services that allow you to list events on the Bristol Fourth of July Committee system and to purchase tickets to or register for events listed on the Bristol Fourth of July Committee website.
3. Most browsers allow you to turn off cookies. To do this look at the "help" menu on your browser. Switching off cookies may restrict your use of the website and/or delay or otherwise affect the way in which it operates.

### **Your Consent**

- By using the Bristol Fourth of July Committee system to purchase tickets or registering for an event, you consent to the terms of this policy. If you do not consent to the collection, use, or disclosure of your personal information as outlined in this policy, please do not provide any personal information to Bristol Fourth of July Committee or on Bristol Fourth of July Committee website.

### **Security**

- No transmission of data over the Internet can be considered 100% secure. However, Bristol Fourth of July Committee takes every reasonable precaution to protect your personal information, privacy, and security. Bristol Fourth of July Committee uses industry-standard SSL-encryption to protect data transmissions (including credit card transactions), firewalls to protect against unauthorized intrusion to our databases, access control procedures, and physical security measures, all aimed at protecting your information.

### **Changes to this Privacy Policy**
